



## **PEC's Home Holiday Lights Contest Terms and Conditions**

September 14, 2021

### **Introduction**

The PEC Home Holiday Lights Contest ("Contest") is sponsored by Pedernales Electric Cooperative (PEC). This contest is governed by these official rules ("Official Rules"). By participating in the contest, each entrant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the contest, as determined by PEC and its agents, are final in all respects. The contest is subject to all federal, state, and local laws and regulations and is void where prohibited by law. Any questions, comments, or complaints regarding the promotion will be directed to PEC.

### **Eligibility**

The Contest is open to U.S. residents where not prohibited by law, who are eighteen (18) years of age or older at the time of entry. All entrants will need to be residential members with homes or meters located in PEC service territory. All entrants must be PEC members in good standing. PEC reserves the right to verify the eligibility of each entrant.

### **Contest Period**

The contest begins November 26, 2021, 9 a.m. CST and ends December 12, 2021, at 11:59 p.m. CST. ("Contest Period"). All entries or submissions must be received on or before the time stated during the Contest Period. PEC reserves the right to extend or shorten the contest at its sole discretion.

### **How to Enter**

Contest participants can enter through the following method: Submitting a photo of their home with an outdoor holiday lights display. Participants will receive one (1) entry into the Contest. Participants are only allowed to enter once per PEC account.

### **Winner Selection**

All entries will be divided into District Offices as chosen in the entry form. Entries will be voted on by staff from the corresponding district office. Winners from the first round of voting will be identified as District Winners. All District Winners will enter a second round of voting, comprised of all PEC employees. The Grand Prize winner will be based on the number of votes and will earn the majority of votes. The winners will be announced on or about December 22, 2021. Announcement and instructions for prizes will be made by contacting the associated member of the winning submission. Each entrant is responsible for monitoring his/her correspondence accounts for prize notification and receipt or other communications related to the Contest. If a potential prize winner cannot be reached by the contest administrator within thirty (30) days, the potential prize winner shall forfeit the prize.

Upon the request of PEC, the potential winner may be required to return an Affidavit of Eligibility, Release and Prize Acceptance Form and IRS W-9 form. If a potential winner fails to

comply with these official rules, that potential winner will be disqualified. Prizes may not be awarded if an insufficient number of eligible entries are received.

### **Prizes**

8 \$250 PEC bill credits

1 Grand Prize \$500 PEC bill credit

District Winners will receive \$250 bill credits, and the contest's Grand Prize Winner will receive a \$500 bill credit.

Incidental expenses and all other costs and expenses which are not specifically listed as part of a prize in these Official Rules and which may be associated with the award, acceptance, receipt and use of all or any portion of the awarded prize are solely the responsibility of the respective prize winner. No substitution or cash equivalent of prizes is permitted.
